Advisory Notes - Additional Rules and Regulations

- i) Should any judge be prevented from fulfilling their engagement, the Committee reserves to themselves the right of appointing other judges to fulfil their duties. Exhibitors are at liberty to withdraw from competition but no entry fees can be refunded.
- ii) Any owner, competitor or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Kennel Club licensed venue and within the environs of that event including car and caravan parks and approaches. Adequate receptacles for the disposal of such fouling will be provided.
- iii) The Committee will do its utmost to ensure the safety of the dogs brought for exhibition but it must be clearly understood by exhibitors and all other persons at the Show that the Committee will not be responsible for the loss or damage to any dogs or property, or personal injury whether arising from accident or any other cause whatsoever.
- iv) An announcement prior to the date of closing of entries in Our Dogs of any alteration or addition made by the Committee to the schedule or in these Rules shall be sufficient notice thereof.
- All children must be kept under control and parents will be held responsible for any damage caused and charges incurred.
- Please do not obstruct gangways with trolleys. Storage space will be made available for trolleys/ cages.
- vii) If in the opinion of the Show Secretary, Show Manager or Judge any dog is considered not in a fit state for exhibition owing to a disease, savage disposition, or any other cause, the dog may be excluded or removed from the show the dog must not be brought into the Show at any time under any circumstances. No animal other than an exhibit duly entered at the show will be allowed within the precincts of the show during its continuance.
- viii) The owner, exhibitor, handler or other person in charge of a dog at a Kennel Club licensed event must at all times ensure that the dog is kept under proper control whilst at the licensed venue, including its environs, car and caravan parks and approaches. This regulation applies before (at any time during the set up period at the venue), during the event and afterwards (at any time during the breakdown of the event)
- ix) A dog may be disqualified by the Board from any award, whether an objection has been lodged or not, if proved amongst other things to have been a) registered or recorded as having been bred by the scheduled judge, this shall not apply to a judge appointed in an emergency; b) exhibited without payment of the appropriate entry fees.
- x) Every exhibitor shall ensure that whilst the dog is being exhibited, its handler shall display the correct ring number.

- 27. Should the judge be prevented from fulfilling his/her engagement, the Committee reserve to themselves the right to appoint a substitute. Exhibitors are at liberty to withdraw from competition, but no entry fees can be returned.
- 28. The Committee will not be responsible for the loss, detention of or damage to any dogs or other property, whether arising from accident or any other cause whatever, or from any act or omission of themselves, their officers, agents, servants or others, and it is on this understanding only that entries are accepted.
- 29. The Committee will not be in any way responsible for any claim for injury or compensation occasioned by or arising out of the holding of the Show or by any other reason or the act or default of any person in attendance or present thereat.
- 30. All persons attending the Show must compensate and/or indemnify the Club for any loss or damage to any property or buildings within the showground caused with or without negligence by any person under the age of 18 years who is brought by them to the Show or for whom they are responsible.
- 31. Sale of Dogs and Acceptance of Dogs For Exhibition. All negotiations for the sale of dogs must be conducted between buyers and sellers. The acceptance of a dog for exhibition shall not be taken to imply that the Committee warrants or guarantees that the dog is in a fit state for exhibition or complies with the Regulations for the Preparation of Dogs for Exhibition and the Committee shall not be liable in any way whatsoever if the dog is subsequently found either to have been unfit for exhibition or not to have complied with the said Regulations.
- 32. Exhibition of Dogs. a) No person shall carry out punitive correction or harsh handling of a dog at any time whilst at the licensed venue, including its environs, car and caravan parks and approaches. b) The owner, exhibitor, handler or other person in charge of a dog at Kennel Club Licensed Events must at all times ensure that the dog is kept under proper control whilst at the licensed venue, including its environs, car and caravan parks and approaches.
- 33. All gangways, fire exits and entrances in the hall MUST BE KEPT CLEAR AT ALL TIMES. Any obstructions will be removed by authorised officials.
- 34. Supplementary Rules. All rules and regulations or definitions or instructions in the nature of rules and regulations printed for convenience in other parts of this Schedule shall be deemed to be the Regulations of the Committee and shall have the same effect as if they formed part of these Regulations
- 33. Final Appeals. Should any question arise not provided for in these Regulations or by Kennel Club Rules the decision of the Committee shall be final subject only to appeal to the Kennel Club.

Use of Electrical Equipment at Shows

The Kennel Club is becoming increasingly concerned at the amount of electrical equipment being used by exhibitors at shows, including hair dryers and hair straighteners and other grooming devices.

Electrical equipment should not be brought to shows unless absolutely necessary. In rare instances where it might be required, it should be PAT tested and permission sought from the secretary of the show before it is used.

The Kennel Club has also been informed of recent instances of exhibitors commandeering certain areas of a venue in order to have access to power points so as to use electrical grooming equipment. This is totally unacceptable and particularly unfair on the breeds whose allocated areas have been cramped because of this selfish behaviour.

Security at shows

In light of recent events the Kennel Club would like to issue a reminder to all Societies of the importance of security at dog shows.

The Kennel Club understands that due to the nature of dog shows and the quantity of paraphernalia exhibitors bring it would be extremely difficult for show organisers to take on the issue of security alone, therefore we would reiterate the advice being given by the Police and security services, that everyone in the UK should remain vigilant and this applies to those organising and taking part in dog shows.

The importance of exhibitors feeling that they and their dogs are safe when attending a show cannot be underestimated. We would therefore remind you of the importance of the need for show organisers and exhibitors to remain mindful of potential dangers and that all visitors generally need to be vigilant and alert.

Furthermore the society should provide robust notification informing exhibitors of where to report to should they see anything suspicious or of concern, and of the evacuation procedures in place.

16. All dogs resident outside of the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.

18. Dogs in Vehicles on Hot Days.

Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under the Kennel Club Rules and Regulations.

Your dog is vulnerable and at risk during hot weather and the Kennel Club offers the following guidance to help guide you through the do's and don'ts travelling to and whilst at KC licensed events.

- When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday route, and leave earlier to avoid increased time in traffic jams.
- If your vehicle is not air-conditioned seriously consider whether travelling to the show is a good idea at all
- The vehicle should be as fully ventilated as possible, and plenty of stops should be taken, with lots of water available to drink.
- Ensure your dog is not sitting in full sunlight. There should be plenty of free flowing air around the dog.
- · When at the show, never leave your dog in the vehicle.
- Keep the dog in the shade take your own shade for example a large umbrella and always have plenty of
 water available to drink so your dog stays well hydrated.
- Avoid your dog taking part in unnecessary exertion, or from standing in exposed sunlight for extended lengths of time.

Remember, if you feel hot your dog is very likely to feel much hotter and dehydrated, and this could lead to dire results. Please look after your dog's welfare. WARNING: IF YOUR DOG IS FOUND TO BE AT RISK FORCIBLE ENTRY TO YOUR VEHICLE MAY BE NECESSARY WITHOUT LIABILITY FOR ANY DAMAGE CAUSED.

- 19. Not for Competition entries will be accepted. Details of each dog so entered must be recorded on the entry form and must be Kennel Club registered .
- 20. No modifications will be made to the schedule except by permission of the Board of the Kennel Club, which will be followed by an advertisement in the Canine press wherever possible.
- 21. Any owner, competitor, handler or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Kennel Club licensed show within the licensed venue and within the environs of that event including car and caravan parks and approaches.
- 22. A dog may be disqualified by the General Committee from any award, whether an objection has been lodged or not, if proved amongst other things to have been: a) registered or recorded as having been bred by the scheduled Judge, this shall not apply to a Judge appointed in an emergency; b) exhibited without payment of appropriate entry fees.
- 23. Every exhibitor shall ensure that whilst the dog is being exhibited, its handler shall display the correct ring number.
- 24. Exhibition of Dogs suffering from contagious or infectious disease or any visible condition which adversely affects their health or welfare. No dog suffering from any infectious or contagious disease or having been exposed to such disease during the period of 21 days prior to the Show or suffering from any visible condition which adversely affects its health or welfare may be exhibited. Exhibitors infringing this Regulation will be liable to be fined and/or to be dealt with under Kennel Club Rule 42.
- 25. Except when securely benched or caged all dogs must be on a lead for the duration of the Show including in the exercising area, except when competing in the ring in an Obedience Class or Agility Test or taking part in a demonstration.
- 26. Judging. A Judge's awards shall be final except in the case of fraud or misrepresentation or where a bona fide mistake has been made by the Judge. No alteration of the awards may be made after the day of the Show without specific permission of the Kennel Club. An award may be withheld if in the opinion of the judge there is lack of sufficient merit. The judge must mark on the judging slips that the award has been so withheld. The judge is not entitled to withold an award for any other reason. When a judge witholds a third award for want of merit, the subsequent awards in that class must also be witheld.

DEFINITIONS OF CLASSES

In the following definitions, a Challenge Certificate includes any Show award that counts towards the title of Champion under the Rules of any governing body recognised by the Kennel Club. Wins at Championship Shows in breed classes where Challenge Certificates are not on offer shall be counted as wins at Open Shows. In the case of a dog owned in partnership and entered in Members' classes or competing for Members' Specials each partner must at the time of entry be a member of the Society.

In estimating the number of awards won, all wins up to and including the seventh day before the first closing date shall be counted when entering for any class i.e. **Monday, 22nd May 2023.** Wins in Variety classes do not count for entry in Breed classes but when entering for Variety classes, wins in both Breed and Variety classes must be counted. A first prize does not include a Special Prize of whatever value.

If an exhibitor reports before the judging of a class or classes that a dog has been entered which is ineligible, the exhibitor may choose one of the following options:

(1) Withdrawal

The dog may be withdrawn from competition subject to the conditions of Regulations 20.

(2) Transfer

- a) If a dog is ineligible for a class or classes as regards its breed, colour, sex, weight or height the Show Secretary shall transfer it to the equivalent class or classes for the correct breed, colour, sex, weight or height and, in the event of there being no equivalent class, Minor Puppy and Puppy excepted to the Open class for the correct breed, colour, sex, weight or height.
- b) If an exhibit is entered incorrectly in a Minor Puppy class, Puppy class or Junior class, which is over age but under 12 calendar months of age, 18 calendar months of age or 24 calendar months of age respectively, the Show Secretary shall transfer the exhibit to the Puppy class, Junior class or Yearling class respectively for the correct breed, colour, sex, weight or height and in the event of there being no Puppy, Junior or Yearling class to the Open class for the correct breed, colour, sex, weight or height.
- c) For any reason other than the above, the Show Secretary shall transfer it to the Open class for the correct breed, colour, sex, weight or height.
- d) If an exhibit arrives late and misses a class, even if it is the only class in which the dog is entered, the dog may not be transferred to any other class.

PUPPY For dogs of 6 and not exceeding 12 calendar months of age on the first day of the Show. **JUNIOR** For dogs of 6 and not exceeding 18 calendar months of age on the first day of the Show. **YEARLING** For dogs of twelve and not exceeding twenty-four calendar months of age on the first day of the Show.

POST GRADUATE For dogs which have not won a Challenge Certificate/ CACIB/CAC/Green Star or 5 or more First Prizes at Championship Shows in Post Graduate, Minor Limit, Mid Limit, Limit and Open Classes whether restricted or not where Challenge Certificates were offered for the breed.

LIMIT For dogs which have not become show Champions under Kennel Club Regulations or under the rules of any governing body recognised by the Kennel Club or won 7 or more First Prizes in all at Championship Shows in Limit and Open classes, confined to the breed, whether restricted or not, at Shows where Challenge Certificates were offered for the breed.

OPEN For all dogs of the breeds for which the class is provided and eligible for entry at the Show. **VETERAN** For dogs of not less than 7 years of age on the first day of the Show.

GOOD CITIZEN DOG SCHEME DOG For dogs that have achieved their GCDS Bronze Award Certificate or above.

GOOD CITIZEN DOG SCHEME BITCH For bitches that have achieved their GCDS Bronze Award Certificate or above.

BRACE For two exhibits (either sex or mixed) of one breed belonging to the same exhibitor, each exhibit having been entered in some class other than brace or progeny.

PROGENY For a dog or bitch, accompanied by at least three of its registered progeny. The dog or bitch not necessarily entered in another class however, all progeny having been entered and exhibited in another class. The dog or bitch and the progeny need not be registered in the same ownership.

SPECIAL BRED BY EXHIBITOR For dogs bred by the exhibitor
SPECIAL NOT BRED BY EXHIBITOR For dogs not bred by the exhibitor
SPECIAL BRED IN THE UNITED KINGDOM For dogs bred in the United Kingdom
SPECIAL BRED OUTSIDE THE UNITED KINGDOM For dogs bred outside of the United Kingdom

ADVISORY NOTICE

NOT FOR COMPETITION Societies may at their discretion, accept Not for Competition entries. Societies may accept such entries from breeds of dog not included within the title of the Society and at Shows held over more than one day, such entries may be accepted on any day from any breed.

RULES & REGULATIONS

- 1. The Show will open at 9.00 am.
- 2. Dogs will be received at any time but it is the exhibitor's responsibility to ensure that exhibits are available for judging when required.
- 3. Judging will commence at 10.00 am.
- 4. Exhibits may be removed from the Show after their judging has been completed. The Show will close half an hour after all judging has been completed.
- 5. The use of cooking stoves in the proximity of the tenting and benching areas is forbidden except as authorised by the Show Management.
- 6. Entry Fees: Members £5.00 first entry per dog, £1.50 each subsequent entry with same dog; Non-members £6.00 first entry per dog, £1.50 each subsequent entry with same dog. Catalogue: £3.00 pre-paid with entries.
- 7. Prize Money shall not be on offer at this show.
- 8. The Committee reserves to itself the right to refuse entries.
- 9. Puppies under six calendar months of age on the first day of the Show are not eligible for exhibition.
- 10. The mating of bitches within the precincts of the Show is forbidden.
- 11. **Best Puppy in Show** Where a Best Puppy in Show competition is scheduled the Best Puppy in Show is a puppy which has competed and is unbeaten by any other puppy exhibited at the same show. A puppy is a dog of six and not exceeding twelve calendar months of age on the first day of the Show. Where the Best in Show is a puppy it should automatically be awarded Best Puppy in Show respectively. Where the Reserve Best in Show is a puppy which has only been beaten by an adult dog it should also automatically be Best Puppy in Show respectively. Consequently, selection of Best Puppy in Show must follow the selection of Best in Show respectively.
- 12. **Best in Show** Best in Show must be selected from the exhibits declared Best of Sex . If a Reserve Best in Show is to be selected, the eligible dogs are those declared Best Opposite Sex and the Reserve Best of Sex to the exhibit declared Best in Show.
- 13. Exhibits will not be admitted to Best in Show competition after a period of ten minutes has elapsed since the announcement that exhibits are required for judging, unless they have been unavoidably delayed by previous judging not being completed on time, and then only with the special permission of the Show Management.
- 14. Exhibitors must not pick up dogs by their tails and leads when lifting them nor handle a dog in a manner which causes its feet not touch the ground when on the move. This is not acceptable. Exhibitors should note that such practice would constitute harsh handling and reports of such practice will be referred to the Committee under Kennel Club Show Regulation F11.
- 15. All exhibitors must be familiar with Kennel Club Regulation F (Annex B) Regulations for the Preparation of Dogs for Exhibition.

REGULATIONS FOR THE PREPARATION OF DOGS

FOR EXHIBITION F (Annex B)

- 1. These regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule A 42.
- (a) a dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained thereat.
- (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach If these Regulation then he/she may be subject to further penalties of either a fine or as listed under Rule A42.
- 2.(a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
- (b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat at the time of exhibition.
- 3.No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:
- (a) Operations certified to the satisfaction of the General Committee.
- (b) The removal of dew claws of any breed.
- (c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown. Nor must anything be done calculated in the opinion of the General Committee to deceive.
- 4.The General Committee without previous notice may order an examination of any dog or dogs at any show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the K.C. in their possession. Samples may be taken tor further examination and analysis.
- 5.An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may however, be lodged by an official of the show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
- 6.Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show & the individual must produce evidence of identity at the time of lodging the complaint.

Regulations now stipulate that competition in AV/Stakes classes has no bearing on the main Breed competition at a show and it is therefore acceptable for beaten dogs to be eligible to challenge in Best Puppy In Group , Best In Group, Best Puppy In Show and Best In Show

The regulation preventing Best Puppy in show from competing in subsequent competition has been made redundant.

Dogs declared Best in Show and Reserve Best in Show do not need to be withdrawn from subsequent competition.
